CONGRESSMAN KEVIN KILEY proudly serves the people of California's 3rd District in the House of Representatives in his first term in office. In his six years in the State Legislature, Kevin introduced the most significant school choice legislation in recent years and authored groundbreaking new laws on protections for sexual assault victims, privacy, criminal justice reform, and freedom of speech. Congressman Kiley is proud to serve on the House Judiciary Committee and was appointed to three subcommittees: the Subcommittee on the Constitution and Limited Government; the Subcommittee on Courts, Intellectual Property, and the Internet; and the Subcommittee on Crime and Federal Government Surveillance. Rep. Kiley also serves on the Education and the Workforce Committee on Early Childhood, Elementary, and Secondary Education.



KATE HUDSON has served at AAU since March 2022. As the Associate Vice President and Counsel for Government Relations and Public Policy, her portfolio includes intellectual property, technology transfer, open and public access, data privacy, and copyright issues. In addition, she supports AAU's policy and federal relations work in areas that require legal expertise, such as tax issues related to research, labor and employment, research security policy, higher education Title IX issues, and other regulatory matters important to America's leading research universities. Kate also leads AAU's General Counsels (GC) constituent group and Intellectual Property & Tech Transfer Task Force.

From 2017 to 2022, Locascio served as vice president for research at the University of Maryland College Park and the University of Maryland Baltimore. She also served as a professor in the Fischell Department of Bioengineering at the A. James Clark School of Engineering with a secondary faculty appointment in the Department of Pharmacology in the School of Medicine. Before joining the university, she was at NIST for 31 years, rising from a research biomedical engineer to leading the agency's Material Measurement Laboratory. Locascio is a fellow of the National Academy of Inventors, the American Association for the Advancement of Science, the American Chemical Society, and the American Institute for Medical and Biological Engineering. Dr. Locascio was recently elected to the National Academy of Engineering.
